Description

The subject property comprises a prominently positioned retail premises located within Bolton Town Centre.

The ground floor offers an open-plan retail area, providing flexible accommodation suitable for a range of uses. The basement level features ancillary accommodation, including a kitchen and W.C. facilities, along with additional open-plan space that can be utilised for storage or further operational needs.

A service access road is situated to the rear of the property, allowing for convenient drop-off and delivery arrangements.

The premises are fitted with suspended ceilings incorporating inset lighting, laminate flooring throughout, and a fully glazed shopfront, enhancing visibility and natural light. Its proximity to the Market Place Shopping Centre makes the property well-suited to a variety of retail operators seeking a town centre location.

Location

The subject property is situated in a prominent position on Corporation Street, a popular shopping parade in the heart of Bolton town centre in the pedestrianised area opposite the Market Place which includes a mix of national retailers such as Next, Hotel Chocolate and Primark.

The property is in close proximity to the Market Place car park and Bolton train station is located within a 10-minute walk.
